### Subject

This is to consider a private storm sewer Encroachment Agreement with Blue Wave Express Car Wash located at the northwest corner of Gardner Drive and State Highway 105.

### Description

This is to allow construction of a portion of the Blue Wave Express Car Wash private storm sewer to be within the city's utility easement. This agreement will release the city from all responsibility for paying for damages incurred by the storm sewers lines as a result of required maintenance and repairs to the public utilities.

Paragraph 4. C. States that the city shall not be responsible to Owner (Blue Wave) for damages to Owners storm sewer drain or other types of improvements in the city's public utility easement. In that same section it says that the city man anytime upon not less than 30 days' notice require the relocation of the storm drainage from along the public utilities and for the purpose of allowing city to make repairs to its public utilities. It goes on to say that the Owner shall relocate the storm sewer improvements promptly at its sole expense and shall not be entitled to compensation of any kind.

Such agreements are fairly often necessary and the complexity of developing a property in an urban setting, with many utilities and conflict.

The City Attorney has reviewed the agreement.

### ENCROACHMENT AND MAINTENANCE AGREEMENT

THIS AGREEMENT is made this \_\_\_\_\_ day of \_\_\_\_\_, 2018, between the CITY OF MONTGOMERY, TEXAS (CITY) and BW MONTGOMERY INVESTMENT, LLC, a Texas limited liability company (OWNER).

#### RECITALS

OWNER is the owner of certain property (PROPERTY) located in the City of Montgomery, Texas at 20210 Eva Street which is being developed by OWNER for a new BlueWave Express Car Wash.

The Property is a 0.82- acre tract of land in the John Corner Survey, A-8, in Montgomery County, Texas, as more particularly described in the plat attached hereto as Exhibit "A."

OWNER is proposing a 4'x4' grate inlet within a 15-inch HDPE storm drainage pipe (hereinafter collectively called the "storm drainage pipe") to be installed within the existing CITY 26-foot public utility easement and across existing public water and sanitary sewer lines on the Property.

OWNER has agreed to regularly maintain the Owner's storm drainage pipe at its sole expense.

CITY and OWNER agree that CITY may in the future need to make major repairs to the public utility easement on the Property. If future major repairs to the CITY's public utilities are required by CITY, the OWNER's private storm drainage pipe may need to be relocated or disturbed in order for CITY to perform the necessary repairs.

The storm drainage pipe shall be the property of OWNER and shall be maintained by OWNER. OWNER agrees that CITY shall not incur the expense of maintaining such or removing or replacing it when any repair work is complete.

CITY has agreed to the OWNER'S installation of storm drainage pipe on and along the public utility easement, subject to the above recitals and the following terms and conditions agreed by OWNER.

### NOW, THEREFORE, be it mutually agreed by OWNER and CITY as follows:

1. <u>Consent to Encroachment</u>. Subject to the above recitals and the terms of this Agreement, CITY hereby consents and allows OWNER to enter upon the above-described CITY easement on the Property for the purpose of installing, placing and maintaining the above-described storm drainage pipe within the CITY public utility easement.

2. <u>Term</u>. This Agreement shall have an indefinite term and shall run with the Property until the CITY and the OWNER, or its successors and assigns, agree to terminate this Agreement.

### 3. Conditions.

- a. Prior to any construction in or along the CITY public utility easement on the Property, OWNER shall obtain all licenses or permits necessary to install and construct the OWNER'S storm drainage pipe or any other improvements on the Property.
- b. OWNER shall be solely responsible for the normal maintenance of the private storm drainage pipe on the Property and shall maintain it to avoid any damage to or interference with the CITY facilities, other public utilities or the general right of CITY to utilize the easement for its intended purpose. CITY shall be responsible for major repairs to the public utility easement (i.e., any work other than the normal maintenance required by OWNER.)

- c. CITY shall <u>not</u> be responsible to OWNER, its successors, assigns, or any other party for damages to OWNER'S storm drainage pipe or other improvements on or along the CITY public utility easement on the Property. CITY may, at any time upon not less than thirty (30) days' prior written notice (except in the event of an emergency), require the relocation of the storm drainage pipe along the public utility easement for the purpose of allowing CITY to make repairs to its public utilities. OWNER shall relocate such improvements promptly at its sole expense and shall not be entitled to compensation or damages of any kind.
- d. OWNER shall notify the City in writing of any change in ownership of the Property.

4. <u>Notices</u>. Any notice required or permitted under this Agreement shall be deemed sufficient if delivered in hand or by First Class US Mail addressed to the parties as follows:

5. <u>Indemnity</u>. OWNER shall indemnify, defend and hold harmless CITY, its elected officials, officers and employees, from any claims, suits, causes of action, costs or damages arising from OWNER'S action or inaction relating to maintenance of the public utility easement by CITY or any improvements by OWNER on or along the public utility easement on the Property.

6. <u>Entire Agreement</u>. This Agreement contains the entire agreement between the parties hereto. No promise, representation, warranty or covenant not included in this Agreement has been or is relied on by any party hereto.

7. <u>Construction and Venue</u>. This Agreement shall be construed in accordance with the laws of the State of Texas. Exclusive venue over any claim or cause of action arising hereunder shall be in the courts of Montgomery County, Texas.

8. <u>Agreement a Covenant Running With the Land</u>. This Agreement shall be recorded in the Real Property Records of Montgomery County, Texas and shall be a covenant running with the OWNER'S land and binding upon the OWNER'S successors and assigns.



### Subject

This is to consider a letter of interest to Texas A&M to participate in the Texas Target Communities Program where students and faculty of Texas A&M produce a communitywide master plan.

### Description

This is to gain a a quality community master plan at no cost to the City. I am familiar with A&M provided plans and have been pleasantly surprised at the cooperation received by the community and by the implementation of the plans that follows the community meetings.

The need for a communitywide master plan has been discussed several times but has been held up each time because of the cost involved. There is no cost to this program to the city other than incidental costs of holding the meetings. Probably less than \$5,000.

This master plan is different from the water and sewer master plan and mobility plan just recently approved by the City Council. This plan would look at the entirety of the city for items such as park needs, financial planning, street work, downtown planning social needs (such as senior citizens needs, the lower income needs, transportation network needs) and city facilities (such as the need for police department, public works and city administration building needs)—plus other subjects that could arise during the public meetings. This is a participatory process where there is a communitywide meeting coordinated by A&M staff and students where the persons attending the meeting are asked their opinions about various community subjects, then are put into committees to work on those particular community subjects. Then committee meetings of those particular groups are held to come up with practical, affordable and specific plans of action to accomplish those community subjects. The City Council is the ultimate approver of the community plan but the plan is particularly written and followed up on for implementation by the various committees.

As stated in the Call for Projects selected projects will be notified by May 15 and planning work will be coordinated with each community between June 2018 and September 2019.

The City of Montgomery Texas is very much interested in your Call for Community Planning Projects initiative. Please accept this Letter of Interest as our community's request for inclusion in the Texas Target Communities (TTC) Program.

<u>Planning Project Need</u> -- The City of Montgomery is a rapidly growing approximately 1,200 population City located approximately 60 miles from Texas A&M University. The future of the city is currently underserved because of not having a community-wide plan for growth. While there have been recent master plans for out water, sewer and mobility needs, there is no community needs master plan for items such as parks, financial resources, social services, community facilities and housing. Also, the community has a fundamental issue about how to keep our small-town atmosphere that includes, lowcrime, community pride, a thriving historic district and historic downtown alive while also accommodating the new growth and new population that seek the quality of life yet threaten it at the same time.

<u>Community History</u> – Montgomery was founded in 1836 and is one of the oldest cities in the state of Texas. Sam Houston was a frequent visitor to the area prior to statehood and after. Montgomery was the original seat of Montgomery County. Montgomery grew as a lumbar and cotton producing area well past the Civil War. Upon statehood, Charles B Stewart, a local resident, became the first Secretary of State of the State of Texas and was the designer of the Texas state flag. From 1900 to approximately 2005 the community stayed as a small commercially centered community in Western Montgomery County. In 2005 to the present, there has been substantial growth in the population and the commercial enterprises in the city. Over the past three years, the City has added approximately 75 new homes per year and approximately \$30 million of assessed value increase per year, with almost all the assessed value increase coming from new residences and businesses. The city now faces multiple, expensive capital improvement projects and a threat to its small-town atmosphere.

<u>Current Conditions</u> -- We need citizens to become more informed and engaged so the effective decision-making in the upcoming decades can result in community resiliency and quality of life. The benefit of a program such as the TTC is to coordinate and hold community focused meetings to identify and leverage local assets resulting in a communitywide plan creating a vision for the future without forgetting the past. This communitywide plan, we understand, will assist in gaining prioritized strategies

and identify needed steps for implementation. The TTC has access to subject matter experts from the academic fields and affiliated state agencies at Texas A&M University to provide this facilitation of the meetings, agreed upon strategies and assignments for implementation.

<u>Ability to Recruit a Diverse Community Task Force of Stakeholders</u> -- Montgomery has long needed such a community-focused plan that is widely accepted and followed. The A and M target communities program, in the City Council's opinion is exactly what the city needs to create a vision for the future, that can provide real-world experience and information on the effects of effective city planning. There are, we believe, interest in the community to produce citizens who will attend and participate in this process.


The city stands ready to cooperate with a point of contact from the University to provide consultation on construction of and implementation of a written planning document and available data is accessible.

Eight projects were developed including 1) Vision and Goal-setting, 2) Land Use Plan and Strategic Growth Plan, 3) Master Drainage Plan (https://oaktrust.library.tamu.edu/handle/1969.1/158350), 4) Transportation Plan, 5) Asset Map, 6) Hospitality Training, 7) Marketing Materials, 8) Youth Citizen Storyteller Program. The final product was the Liberty Strategic Plan 2016- 2036, which is the official policy guide for the community's growth over the next twenty years.

The Class of '69 worked with a landscape architecture course to redesign a plaza on Texas A&M UNiversity's campus to focus attention to the Aggie traditions of Muster and Silver Taps.


