Type A City (Local Gov't Code, Section 22.032) Mayor – Residence – 1 yr in state before filing deadline; 1 yr in city prior to election day. Age 18 and must be a registered voter in territory elected from by the filing deadline. Councilmember – City Council – Residence – 1 yr in state prior to filing deadline; 6 months in the city prior to filing deadline. Age 18 Must be a registered voter in territory elected from by the filing deadline.
