Present were: Kirk Jones, Randy Moravec, Bob Kerr, Cheryl Fox, Bill Hanover, and Andy Dill. John Champagne was absent. Also present was Glynn Fleming and Jack Yates.

Call to Order - President Jones called the meeting to order at 6:00 PM.

Open Public Comment - There was no public comment

<u>Approval of Minutes of May 16, 2016</u>- Motion by Moravec seconded by Hanover to approve the minutes as presented. All in favor.

Monthly Financial Report (May)--Mr. Dill asked about the tent expenditure being present on the budget as an expenditure, Mr. Moravec replied that the expenditure and the revenue were a counter accounting entry that would not show up in the budget. Following discussion it was decided that Jack would ask the auditor's opinion that the auditor's opinion would be the ultimate decision of how to handle the accounting. Motion by Moravec, seconded by Fox to approve the monthly financial report as presented. All in favor.

Presentation of Antiques Festival Report- Tiffany Lockhart -- Tiffany Lockhart presented the report that was in the packet showing a \$11,659 net income for the Festival. Mr. Moravec asked what would be done with the net income, Ms. Lockhart responded that the downtown businesses would be discussing having more events and to otherwise plan future activities. Ms. Lockhart said that the downtown businesses were pleased with the event. Mr. dill asked about if they checked out where the visitors came from with a response that the shuttle drivers had asked misters and his response was that the newspaper advertising/Facebook resulting in the visits from all over the metro area. The Board congratulated Ms. Lockhart on the thoroughness of the report.

Parking pavement project north of community center — Pres. Jones suggested completing the project since the project is in the MEDC budget. Glynn Fleming said that he had an estimate for concrete and one for crushed aggregate. He said the concrete was more permanent but that he was concerned with drainage, that the painting would be under the tree line, and in order 6 inch water line would be under the pavement. He said that there would probably be 16 to 17 parking space created. Due to the 25 that depth between the pavement of Clepper in the rock wall is called for angled parking in order to protect the rock wall. Mr. Hanover asked about relocating the wall, the answer was that it was possible but expensive. Jack Yates said that the zoning ordinance required hard surface pavement for businesses and that it would be difficult for him to explain that the city paved with crushed aggregate.

Staff was advised to obtain an asphalt estimate for the project.

<u>Fernland and Memory Park Sidewalk Project</u> – Jack Yates reported that the two sidewalks planned are currently gravel pathways that get washed away at heavy rains. Following brief discussion, Mr. Moravec suggested that the funds for the project of \$2260 be taken from the Fernland line item in the budget and that the budget be later amended to show the expenditure. Motion by Moravec seconded by Hanover to approve the project expense. All in favor.

<u>Economic Development Report – Shannan Reid</u> – – Ms. Reid was not present, but had given the Board a report. The report was briefly discussed. Mr. Moravec asked about the Lone Star College interest. Mr. Dill, and other members of the Board, responded that they considered several positive factors in belonging to the Lone Star College System.

There is also discussion about an Economic Development Roundtable of area businesses and

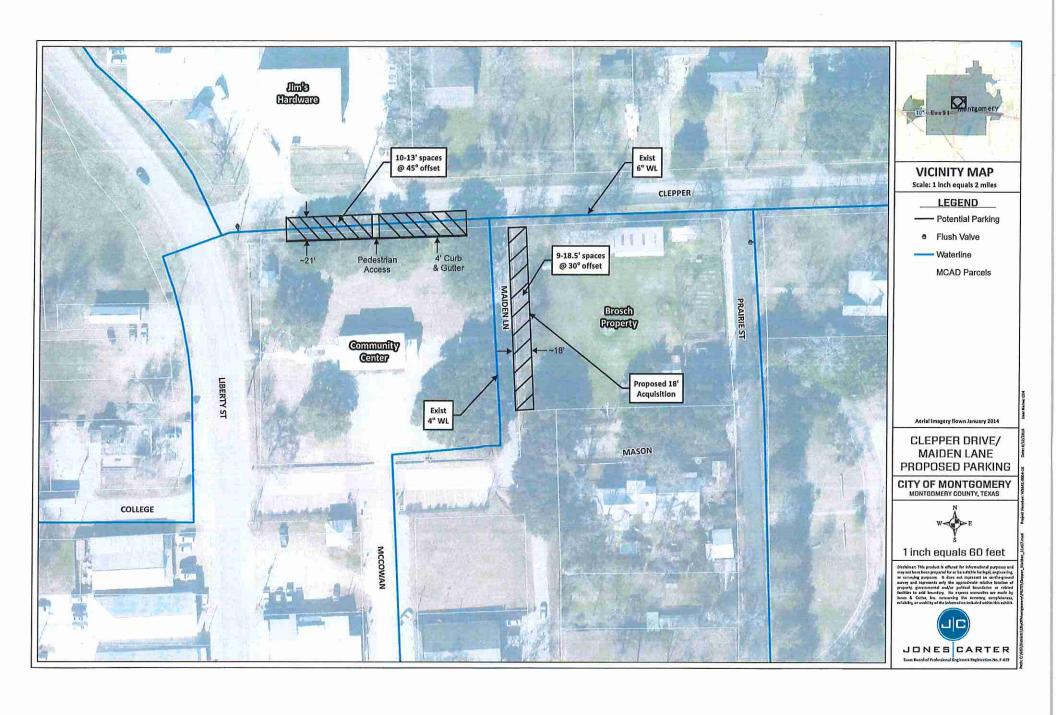

MEDC BUDGET - DETAILS

Attached is the Proposed MEDC 2016 Budget. Below is an explanation of each line item intention- I say intention because, please remember that the budget is more than just figures, it is the intended actions of the MEDC from October 1st, 2016 to September, 2017.

Not all of these intentions will happen during the upcoming year and there, almost certainly, will be new actions that you will decide to undertake during the upcoming fiscal year.

All of this is to say that the budget is as much a goals policy as a financial plan that can be amended during the year.

You may note that the budget has a planned surplus of expenditures over revenue. That will be the case if every dollar is expended during the year, which is not likely. The MEDC has a projected year-end balance of approximately \$697,150 and the projected use of \$169,600 (the amount expenditures are over revenues for next year) would come off that number. But keep in mind, for instance, the current year had a projected expenditures of \$98,150 and we actually expect to not dip into the balance at all this year, because not every expenditure happened that was budgeted.

Revenues

- -Sales Tax Sales tax for the city overall is expected to increase.
- -Interest Income this is interest income from the balance in MEDC funds

Expenses state law states what can come from each category

Category I ---

-Downtown Improvements – the thought is that the \$10,000 from the builder of the new building at McCown and College will be paid and with that money and \$25,000 from the MEDC that a paved parking area will be placed along Clepper

Street north of the Community Center. \$10,000 for planned improvements to drainage/sidewalks/streetscape improvements in downtown area.

- -Utility Extensions This will be \$75,000 toward the Texas Capital Fund grant to get utilities to the Pizza Shack development –already agreed to by MEDC. The remaining \$50,000 is for future possibilities that may come up during this next year. \$75,000 for the McCoy's sewer line size upsizing.
- -Flagship Boulevard improvements-this involves landscaping on the north side of Flagship Boulevard, to screen the back of the shopping center from the apartments and otherwise beautify Flagship Boulevard.
- -Transfer to debt service. Increase from \$117,500 in the past to \$177,500 due to another borrowing by the city for water and sewer dates.

Category II

-Economic Development Grant Program – This is where a grant is made to a historic area business or home to make an improvement to their façade, structure or public use aspect of their building. The grant maximum is \$5,000 and are individually applied for and awarded by the MEDC Board.

Category III

- -Seasonal decorations- involves some additional monies and upkeep/additions to the trees purchased earlier this year.
- -Christmas Lighting this helps the Civic Association with funding for their lighting of Cedar Brake Park and downtown during the holidays.
- -Walking tour- The MEDC for three years has budgeted for this "Q- code" walking tour of the historic district that will involve signing, printed materials and other amenities involved in the tour.
- -Downtown Enhancement Projects This involves some planned streetscaping improvements to the downtown area. This may involve drainage/ benches/ trash cans, sign posts, trees, etc.
- -Removal of Blight This is for removal of old houses/structures having to do with the appearance of the city. The city is starting a process on five such structures and the \$30,000 will go toward those removal expenses.
- -Downtown Signs This is for the upkeep of the new electric sign at the corner of 149 and 105.

-Fernland Improvements— This will contribute toward the restoration and maintenance of the Park's inventory of buildings and artifacts of Fernland Park.
-Heritage Village Detention Pond Improvement — This is an old MEDC agreed to do project to help the Heritage Apartment builder finish their detention pond so that public use can be made of the pond.

Category IV

- -Promotional Video The MEDC two months ago gave Shannan Reid permission to work with the producer of the MEDC community video to update the video. That work is in progress and will be paid from next year's funds.
- -Brochures Printed Literature This involves an advertisement in a Woodlands Chamber publication and other brochures and mail outs during the upcoming year.
- -Christmas in Montgomery -- the MEDC for several years has contributed to this local event that brings in persons for the event that generally "sells" Montgomery to visitors and locals alike.
- -Wine and Music Festival- the MEDC for several years has contributed to this local event that brings in persons for the event that generally "sells" Montgomery to visitors and locals alike.
- -Antique Show and Festival-- the MEDC for several years has contributed to this local event that brings in persons for the event that generally "sells" Montgomery to visitors and locals alike.
- -Texian Heritage Festival -- the MEDC for several years has contributed to this local event that brings in persons for the event that generally "sells" Montgomery to visitors and locals alike.

Category V

- -Admin. Transfer to General Fund This is what MEDC pays for City support of MEDC, meaning the financial record keeping, my time and overall city support of MEDC economic development matters.
- -MACC Administration and Office This is payment to the Montgomery Area Chamber of Commerce for Shannan's Reid's time and office spent on economic development through the Chamber.

- Staff Support person-- Additional staff person for either as a staff person for hiring by the MACC or as a half-time employee of city as a Special Events Coordinator for discussion/decision by the MEDC/City Council. Also, an internship program for high school/college students from city to work in city businesses hopefully getting them trained/connected to a job that will keep them in the city after graduation. It is thought to be a cooperative program with local businesses wherein the local business pays half the pay to the intern and MEDC matches up to \$3,000.
- Miscellaneous Expenses Just as it reads, minor expenses of the MEDC that do not seem to fit into any specific line item budgeted. A drone purchase is proposed.
- General consulting (Acctg., Eng., Legal) this is in case there is some specific engineering or legal work or advice needed for the MEDC due to looking at some specific issue, plus it could pay for the economic development analysis programs that MEDC has done on two recent occasions to analyze requested infrastructure contributions to a specific business.
- Travel and Training Expenses -- Travel for MEDC members or staff to various trainings, seminars, etc.

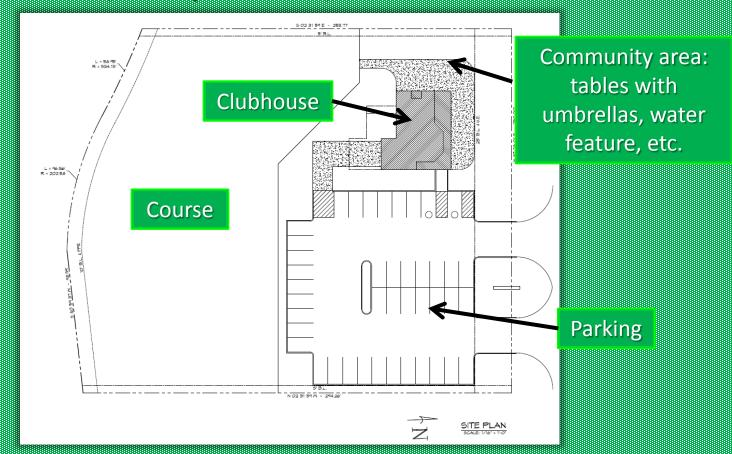

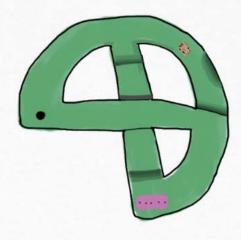
- To that end, we want our course to be three things, predominantly:

- Botanical The other item that is very important is the botanical feel of the course. We want there to be a well laid out landscaping plan that involves native Texas trees (e.g. Magnolia trees) and flowers as well a lot of water features.
- Replay-ability Green designs can be all manner of difficulty levels, but default to mildly difficult in skill level, to encourage repeat visits to master the technical demands of the course.

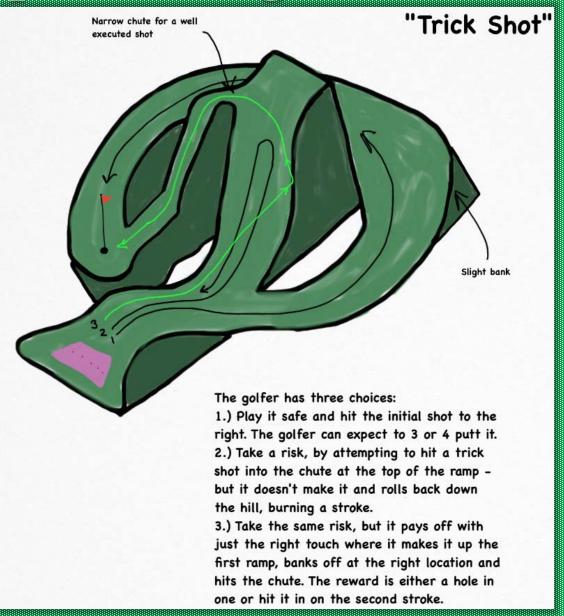
"Over/Under"

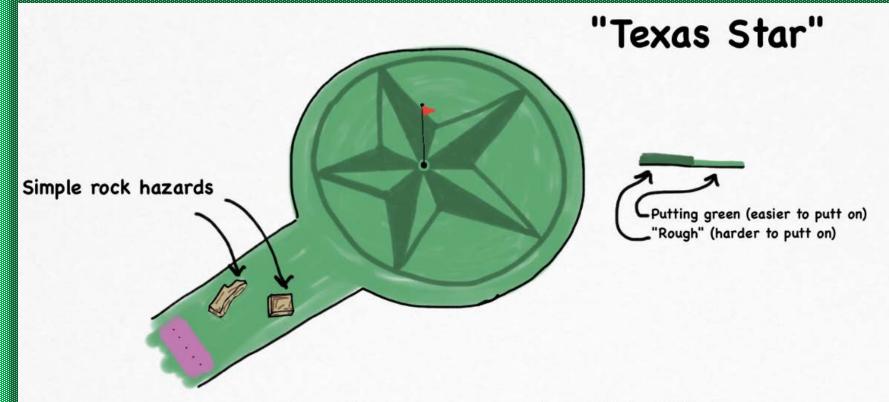


The golfer has two choices:

- The safe route is to putt it straight ahead, down the ramp which carries it up the next.
 The golfer can then two putt it from there.
- 2.) The riskier, but greater reward shot, is to lightly putt it so it has visibility for the next shot to go over the bridge. If the golfer hits it too strongly, however, the shot will carry over the ledge, which will then result in two or three extra shots to get it in the hole, because of the extra hazards that the golfer must navigate.

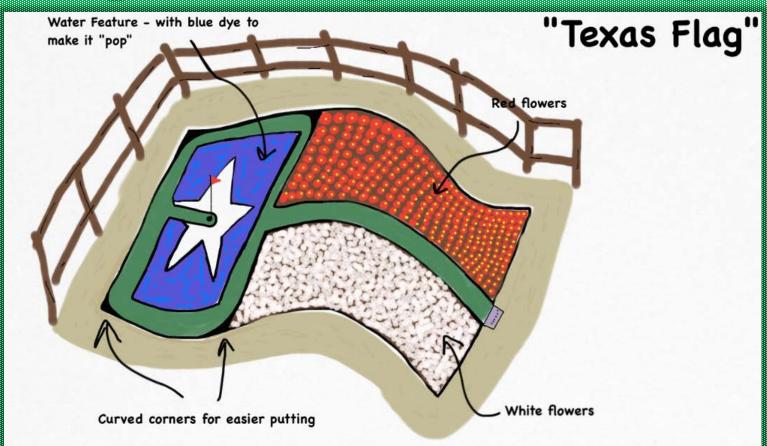






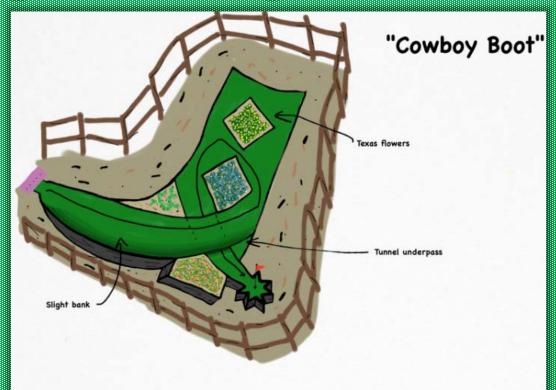
The golfer has one approach, avoid the initial obstacles, combat the difference between the putting green (lighter green) and the "rough" (darker green).

Another nod to Montgomery's/Texas's heritage, more so, then a risk/reward hole.

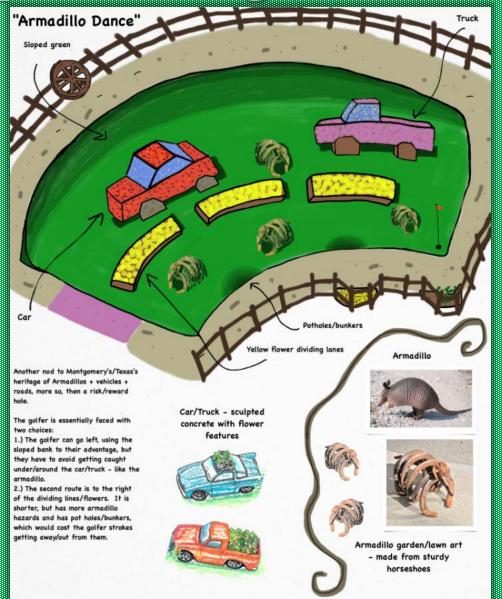
The golfer would use the curves in the flag's outline to best navigate this particular course.

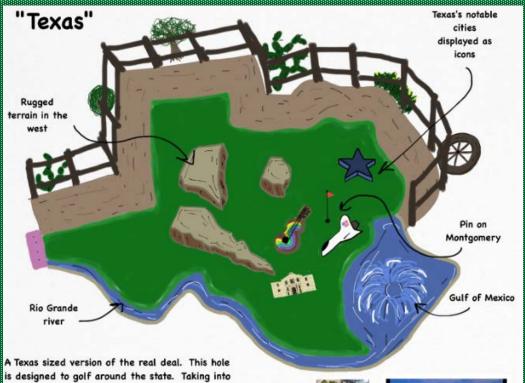


An homage to Texan's choice for footwear - the tried and true cowboy boot.

There will be spaces on this hole for flowers to provide some ornamentation; an opportunity to give the boot some panache.

The over/under approach allows for the golfer to see the entire course, with the goal being the pin in the middle of the spur.





A Texas sized version of the real deal. This hole is designed to golf around the state. Taking into account topographical features (e.g. rugged terrain in the west, flatter land features in the east).

In addition, the golfer has to navigate the "Rio Grande river", on the south side of the state. Otherwise, the golfer must contend with rock features.

Lastly, notable icons are used to mark Texas's notable cities, while providing the golfer an opportunity to use them for bank shots or to avoid.

MEDC participation in 12" upgrade to deeper sewer line to serve S. Hwy. 105 area and McCoy's Lumber.

Discussion

As previously presented at the May MEDC Board meeting the issue is a MEDC financial participation in a upgrade from an 8 inch sewer line to a 12 inch sewer line placed at a larger depth as suggested by the city engineer, the deeper depth eliminates one lift station that the city currently has in place, the saving upgrade and replacement cost at some point in the future, and a cost of several hundred thousand dollars.

With the upgrade in size and deepening of the line the cost to the city is estimated to be \$100,000. The previous estimate was approximately \$75,000.

This new line is approximately 2,150 linear feet connecting FM 2854 with the existing sewer line that now ends east of the First Baptist Church - thus creating a ready-for-development zone that is now undevelopable thus creating a sizeable sales tax potential area.

If the MEDC does not agree an 8" inch sewer line will be laid by McCoy's, but is undersized for any other development to connect to.

The present cost estimate provided by McCoy's for the 12 inch line is \$210,662. McCoy's is willing to pay \$110,662 of the total, and is asking for \$100,000 from the MEDC to fund the remaining part of the price. The upgrade, and particularly the deepening of the project is a very costly part of the construction.

Glynn Fleming believes that the \$210,662 is a high estimate and that the project will receive bids considerably lower than that figure. If the actual bid does come in under the \$210,662 then the \$100,000 will be reduced by that number—i.e. if the bid were to come in at \$200,662 then the MEDC share would be \$90,000.

McCoy's is now ready to proceed and is planning to have their construction plans approved at the August 23rd Council meeting.

Recommendation

Approve the expenditure, not to exceed \$100,000 with final determination to be based upon the actual bid.

Sanitary Sewer Extension to Serve Proposed McCoy's Building Supply

Dear Directors:

As you are likely aware, the McCoy Corporation has selected the City of Montgomery as the location of the newest McCoy's Building Supply store. We along with the City Administration have worked closely with the McCoy's real estate development and engineering teams over the past few months to complete the pre-development feasibility and preliminary platting phases, and your City Council is scheduled to act on a rezoning request for the tract later this month. As identified in the predevelopment feasibility study, this tract will require an extension of the City's existing sanitary sewer system in order to receive service. This extension will consist of approximately 2,150 linear feet of gravity sanitary sewer line and associated appurtenances. It will commence at the westernmost property line of the McCoy's Tract and extend east along the southern right-of-way of SH-105, terminating at an existing City of Montgomery man hole located southwest of the intersection of SH-105 and FM-2854. The McCoy Corporation has stated their willingness to fund the engineering design and construction cost of an 8-inch sanitary sewer line, which is sufficient to serve the entirety of their proposed development. Per Section 90-103(10) of the City of Montgomery Code of Ordinances, if the City deems it prudent to install a line larger than that required to serve a development, the City must fund the additional cost associated with increasing the proposed line size. For future planning purposes we recommend the City elect to fund a larger diameter extension. Construction of a 12-inch sanitary sewer line rather than an 8-inch will facilitate service to future commercial development along the southern right-of-way of SH-105 and may aid in the future elimination of City Lift Station No. 12 and redirection of City Lift Station No. 3.

At the City's request and in response to the correspondence regarding the cost sharing of the proposed 12-inch wastewater line to be extended along Eva Street as part of the McCoy's Building Supply project, Eckermann Engineering, Inc. (EEI) solicited a bid for the installation of +/-2,180 linear feet of 12-inch wastewater line. The line is proposed to extend along the southern side of State Highway 105 (Eva Street) from the existing manhole located southwest of the intersection of State Highway 105 and FM 2854 to the western property line of the McCoy's Building Supply development.

It was previously agreed that McCoy Corporation will pay for the cost to extend an 8-inch wastewater line along the alignment and that the City of Montgomery will pay the associated costs to upsize the line to a 12-inch and deepen the wastewater line to serve future developments to the west. A bid was received from Embree Construction Group for the 12-inch wastewater line based upon the approximate quantities provided by EEI. The 12-inch wastewater installation cost totaled \$210,662 and is attached to this letter for reference. When compared to the \$81,600 construction cost estimate for the 8-inch wastewater line, referenced in the Jones and Carter Utility Feasibility report, this represents a cost increase of \$129,062 plus engineering/surveying costs of \$23,100.

On behalf of the Developer, McCoy Corporation, we would like to request the following cost participation and consideration from the City of Montgomery, as referenced in the Memorandum of Understanding generated from the May 3, 2016 meeting.

- Allow McCoy's to design and construct the 12-inch wastewater line along State Highway 105, with City review, as part of the overall development project.
- Upon completion and inspection of the said wastewater line by City representatives, the City of Montgomery will reimburse McCoy Corporation \$100,000 to offset the costs for the deepening and upsizing of the wastewater line. (The referenced \$100,000 represents approximately 75% of the additional construction costs excluding soft costs).
- McCoy's to pay for all engineering and design associated with the extension of the 12-inch wastewater line.

MEMORANDUM OF UNDERSTANDING

On May 3, 2016, representatives from McCoy's Building Supply and the City of Montgomery, Texas met to discuss the charges and fees related to City utility services provided to the proposed McCoy's store in Montgomery. In accordance with the City ordinances, the parties agreed to the following:

- 1. McCoy's will be paying only for the taps that will serve their store. Tap fees on the other three tracts (Reserves) on McCoy's property will be paid by the land owner/developer at the time of development.
- McCoy's will design, with City engineering review, and construct, under City inspection, 2. approximately 2,150 LF of 12-inch gravity sanitary sewer line. This line shall be placed within an existing utility easement which parallels the southern right-of-way of SH-105 and shall commence at the westernmost property line delineating the McCoy's tract and the First Baptist Church tract. It shall then extend east, with approximately seven man holes placed at necessary intervals, and will terminate at the existing City of Montgomery sanitary sewer man hole located southwest of the intersection of SH-105 and FM-2854. McCoy's will fund all engineering design costs and the construction costs associated with an eight-inch gravity sanitary sewer main and appurtenances. For future planning purposes the City of Montgomery desires this line to be constructed as a 12-inch sanitary sewer main, and as such will fund the difference in material and construction costs between eight-inch and 12-inch pipe. Additionally, the City will be examining the possible benefit in lowering the finished flow line to aid in future planning. In this event the City will fund the additional construction cost associated with lowering the finished flow line.
- 3. The City will not reimburse McCoy's for its cost in installing the 8 inch sewer line.
- 4. McCoy's engineer will design the sewer line with review and approval by the City engineer.
- 5. McCoy's has the option of either paying the City for the installation of the sewer line by a company selected by the public competitive bid, or doing the construction itself without a public competitive bid with inspection by the City.
- 6. Inspection costs will come from escrow funds held by the City.
- 7. A note will be added to the McCoy's Montgomery Subdivision Final Plat illustrating that 65.7 Living Unit Equivalents have been reserved to support the ultimate build-out of the 10.35-acre tract. The anticipated breakdown per Reserve is:

Reserve A (McCoy's) – 12.7 LUEs Reserve B (Possible Restaurant) – 14 LUEs Reserve C (Possible Restaurant) – 14 LUEs Reserve D (Possible Hotel) – 25 LUEs

8. A separate sheet showing the anticipated tap fees is attached to this memorandum as Exhibit "A".

I spoke Embree and they should be able to get 3 updated bids from local utility subs on the 12" wastewater line in the next couple of weeks. This bid will include all of the items to complete the work within the off-site 12" wastewater line plan set.

At the same time we will also ask the contractors to price an 8" wastewater line option with the following assumptions:

- Follow the same general alignment of the 12" wastewater line.
- Follow the same general slopes as the 12" wastewater line.
- Include a bore and encasement under Buffalo Springs as shown in your comments from yesterday.
- Reduce the depth of the overall line so that the manhole located at Station 22+82.63 (NW corner of the McCoy's tract) is 4 foot deep minimum.

Are these assumptions acceptable?

If so, then McCoy's is ok with the presentation to the MEDC on Monday night being a maximum cost sharing of \$100,000 to be backed up by bids to follow at a later date. Thanks,

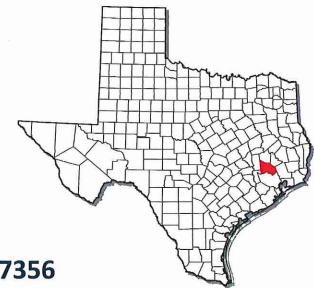

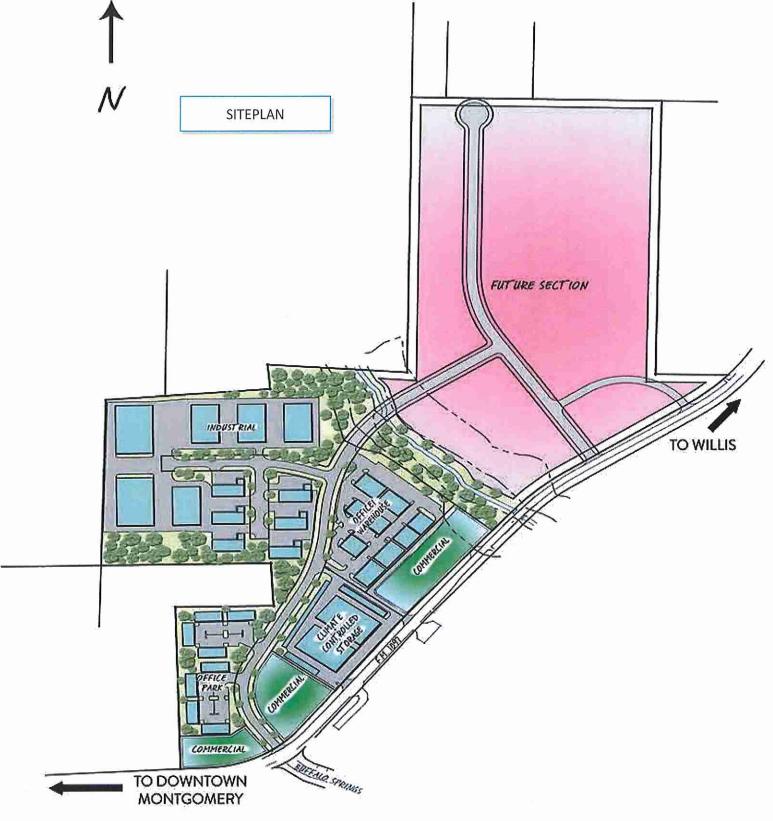

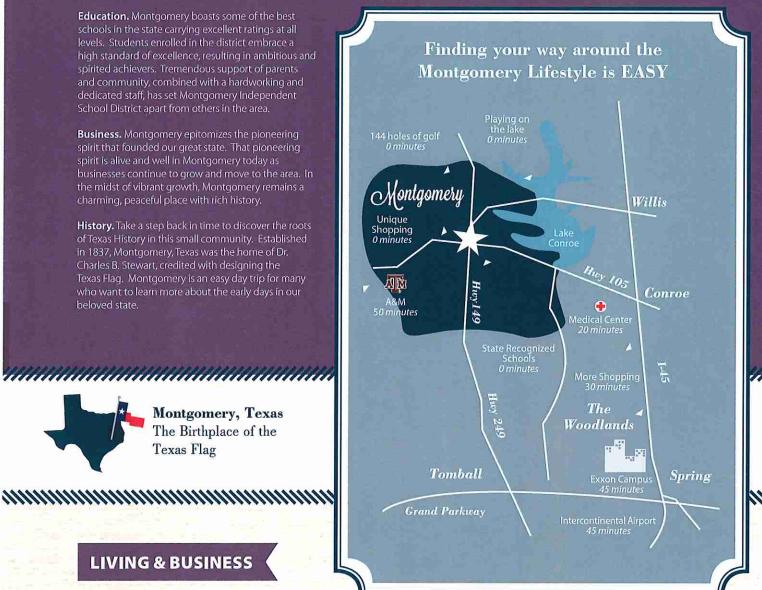

I made the following list from Rick Milne's notes for the projects our church completed in the blighted area of the city off MLK street. After your inspection of the sites, and if the work meets your understanding of our agreement of work to be completed, you can mail the city's \$1,000.00 check as follows:

First Montgomery Baptist Church Attn: Kay Piland P.O. Box 189 Montgomery, Texas 77356

- · FBM provided general cleanup services around the Shoemaker and Baja Street properties in Montgomery, starting the week of 17 July 2016, with the concentration of work starting Monday morning 18 July 2016. General clean up included yard cleanup (i.e. mowing, trimming and trash pick-up) as well as organizing yard to provide curb appeal. No painting will be provided at this time.
- The City of Montgomery provided a dumpster at the Shoemaker house Monday morning, any trash from the Baja house was brought by FBM to the dumpster at the Shoemaker house.
- The City of Montgomery coordinated the delivery and placement of the dumpster with the property owner, FBM will coordinated the items to be trashed with the property owner.
- FBM removed the fallen tree from the trailer at the Shoemaker house, as reasonable, considering the safety aspects of size and weight. However, further demolition and removal of the trailer was not part of the project.
- · FBM provided all the labor and equipment to conduct the clean-up task described above. The work groups started around 8 am in the morning, and convene around lunch time (noon) before the heat of the day.
- The City of Montgomery agreed to reimburse FBM the amount of \$1,000 (\$500 per home) for the work described.
